News and Updates

Representation and Dissemination through International Events

In the month of November a FIP Education representative participated in two conferences. Please find a short summary of the outcomes below:

The 4th Global Health Supply Chain Summit, University of Southern California

Los Angeles California | 3rd and 4th November by Andrew Brown

Approximately 80 participants from a variety of governments, NGOs and development partners met under the theme of **Human Resources for Medical Supply Chain Management**. The focus of the conference was to highlight **the need** for a more directed focus on the **human resources** required for **medical supply chain management**. A focus on a **needs based country approach** was put forward, with a need to ensure that there are adequate numbers of people with appropriate **education, training and workplace support** for the medical supply system to function properly.



Pharmacists were seen as **playing an important role** in the **selection, and use** of **appropriate pharmaceuticals** while care needs to be taken to develop appropriately competent staff for all aspects of **medical supply chain management** given the available resources for specific country environments.

Andrew Brown presented his paper titled **Innovative education to support MDGs – Essential Medicines Supply Competency development through the use of innovative culturally based teaching methods specific to various cadres** with Mr Peter Zinck (Health Systems Specialist, United Nations Population Fund, Suva, Fiji). This paper showcases the project Andrew is currently involved with in **Pacific Island Countries** with a focus on **Pharmacy Support Workforce cadres**, their **competency requirements** and **innovative ways to train them**.

Port Moresby, Papua New Guinea | 7th to 9th November by Andrew Brown

Theme - Effective Medical Management Ensuring Universal Access

Established in 2009, PSPNG has an interest in joining FIP and learning about *FIPeD* initiatives. They invited Andrew Brown to be the keynote speaker at their conference to share the **results of his research in medical supply systems and Pharmacy Support Workforce** while also interested in hearing of *FIPeD* initiatives. Approximately 50 participants attended the conference with representatives from **community, hospital, academic and government pharmacy**.

The society is preparing key resolutions to put to their national government following the conference in an attempt to focus the government's attention on **human resource issues for the medical supply chain and education requirements for Pharmacy Support Workforce cadres**.

FIP-WHO Global Survey of Pharmacy Schools | Has your school responded?

As part of the Global Pharmacy Education Taskforce (PET), the World Health Organization (WHO) and the FIP are undertaking a collaborative programme of work to **develop evidence-based guidance and frameworks** through which to facilitate the **sustainable development of higher education** and a **needs-based pharmacy workforce**.

WHO and FIP are now implementing a **global survey** that aims to collect information:

- To ascertain the **educational background** of the **pharmacy workforce and production capacity**;
- To ascertain **quality assurance accreditation** mechanisms and processes.

The data will be used to **identify gaps, shortages and cooperation opportunities**, and will provide the **evidence-based information needed for investment policies** that will reduce existing gaps and **increase pharmacy education capacity**.

The participation of all pharmacy education institutions in this survey **is vital** to provide a better understanding of **current pharmacy education issues** and assist in the development of **global pharmacy education policy recommendations**.

For these reasons, FIP and WHO have sent an invitation to the **Deans of all schools of pharmacy** to complete the **Global Survey of Pharmacy Schools**. Please help us by ensuring that your Dean or School leader has completed the survey for your pharmacy school/faculty/department.

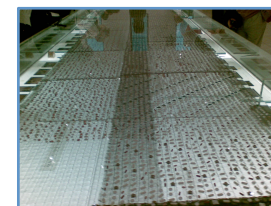


'Seven Billion Humans and 98 Trillion Medicine Doses'

This article is a viewpoint inspired by a contemporary art exhibition at the British Museum entitled 'Cradle to Grave' where more than **14,000 tablets and capsules** were stitched into a fabric, representing a **lifetime prescription of a typical British person**. It reflects about the **pharmacy profession**, the **capacity needed as a workforce** - not only in terms of numbers of **medicines' experts** to address shortages but also on the **specific roles** that a **pharmacist** should be prepared to **perform** - and whether the present **educational models** are appropriate to fulfill those requirements. It concludes with a question 'How Can We Get There', where the authors provide a vision based on **evidence of the way forward**.
