## **CONGRESS 2010 ANNOUNCEMENTS AND EVENTS**

The **FIP Pharmacy Education Taskforce** and **FIP Academic Section** are organizing a full-day satellite session on Education to be held before **FIP Congress 2010 in Lisbon, Portugal**. Please join us for this interactive session “**R1: HOW TO DEVELOP ACADEMIC CAPACITY TO ENSURE SEAMLESS EDUCATION**”, with topics such as: Teacher Training and Capacity Development; Continuing Professional Education: Seamless or Not?; and The Learning Journey - Developing a pharmacy education roadmap. It will be held **Saturday, 28th August 2010 from 09:00 – 17:00**. The cost for the session is **55 Euro\***.

The session will feature case studies, group discussions, debates and an “**ideas showcase**” poster and short oral presentations derived from abstract submissions. R1 will be of particular interest to faculty, practitioners, researchers, regulators and policymakers who are involved with activities such as: teacher training and faculty development; practitioner development and mentoring in practice settings; or innovative ideas for a new vision of seamless professional education. However, registration is open to anyone from any background.

All participants are invited to submit abstracts at: <http://bit.ly/d4GYkE>. Subsequent to the session, the abstracts will be published in the international peer reviewed journal *Pharmacy Education*. The deadline for abstract submission has been extended to **Friday, 11 June 2010**.

The Taskforce and the **FIP Young Pharmacists’ Group** are also co-organising the second **Learning to Teach Workshop** to be held at the Lisbon Congress. This session will offer attendees a half day of interactive, thought-provoking small group discussions, case studies and panel discussion on concrete action plans to use within their teaching and learning environments. The unique aspect of this session is the rich diversity of faculty from around the world, with various backgrounds of experiences, and many novel tools to share. **R5: Learning to Teach Workshop** will be held **Sunday, 29th August 2010 from 09:00 – 12:00**. The cost for the session is **35 Euro\***.

An important education event for all to attend at the congress this year is the **5th Annual Global Pharmacy Education Consultation** on **Tuesday 31 August 2010, 09:00 – 12:00**. Anyone registered for the Congress can attend. The Taskforce invites all to participate and to celebrate the achievements made over

the past 2 years of implementing the Pharmacy Education Action Plan. During the session all participants will be able to provide input into the future focus on and development of Pharmacy Education in FIP.

The Project Team for Quality Assurance will hold a session during **FIP Congress 2010** in Lisbon. Mark your calendars for **Monday 30 Aug from 12.30-13.30**. Project Lead for QA, Mike Rouse, will chair the event, entitled **“The Updated Global Framework for Quality Assurance of Pharmacy Education.”**

**The World Bank** is now offering free access to more than 2,000 financial, business, health, economic and human development statistics that been available previously only to paying subscribers.
